A public hearing will be held at the Department of Workers' Claims on January 22, 2021 at 10:00 a.m. (ET) to receive comment regarding proposed changes to the following administrative regulations: 803 KAR 25:170, Filing of claims information with the Department of Workers' Claims; 803 KAR 25:175, Filing of insurance coverage and notice of policy change or termination; 803 KAR 25:185, Procedure for email notification of cancellation or removal of location of specific workers' compensation coverage.
